- ABSOLUTELY NO DRUGS OR ALCOHOL ON THE PREMISES

- Guests are allowed 2 visits before membership is required.
- No sidewinder drawing of bows, no cross shooting at targets.
- The range is closed to open shooting during any organized shoot or work party.
- No children are to be left unattended. Parents are responsible for their child's safety.
- All shooters and their guests are liable for their own actions.
- Please return any arrows found on the range to the Lost Arrow Box under the pavilion.

Members Must READ BEFORE SIGNING:

ARCHERY CLUB WAIVER AND RELEASE OF LIABILITY

In consideration of being allowed to participate in any way in **Sandia Crest Bowhunters Association** events and activities, the undersigned (and their guests) acknowledges, appreciates, and agrees that:

- 1) The risk of injury from archery and other known and unknown events and activities and/or the use of the related buildings, structures, equipment, automobiles, firearms, weapons, ATV's, boats, tree stands, roads, bodies of water, land and all other real and personal property whether owned by archery club or others is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
- 2) I (and my guests) acknowledge and agree that the use of archery equipment, firearms and other weapons by myself or others on club premises or otherwise are inherently dangerous and high risk activities whether such archery equipment, firearms or weapons are discharged by myself or others; and
- 3) I (AND MY GUESTS) KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASES or others, and assume full responsibility for my participation; and,
- 4) I (and my guests) willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
- 5) I, for myself (and my guests), and on behalf of my heirs (and theirs), assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS **Sandia Crest Bowhunters Association, Bernalillo County**, its officers, directors, officials, agents, employees, volunteers, members, guests, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of real property and personal property used to conduct the events and activities ("RELEASES"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASES OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW.
